4. First Aid Measures

7. Handling and Storage

Precautions for safe handling: Avoid contact with skin, eyes, and personal clothing. Wash hands thoroughly after handling. Avoid breathing fumes. Use only with adequate ventilation. Wear suitable protective clothing, gloves, and eye/face protection. Keep away from sources of ignition. Minimize dust generation and accumulation. Keep container tightly closed. Open and handle container with care. Do not eat, drink, or smoke while handling.

Conditions for safe storage, including any incompatibilities: Store in a tightly-closed

container when not in use. Store in a cool, dry, well-ventilated area away from incompatible substances. Keep away from sources of ignition. Store long-term at 2-8°C.
