4. First Aid Measures

7. Handling and Storage

Precautions for safe handling: Avoid contact with skin, eyes, and personal clothing. Wash hands thoroughly after handling. Avoid breathing fumes. Use only with adequate ventilation. Wear suitable protective clothing, gloves, and eye/face protection. Keep away from sources of ignition. Minimize dust generation and accumulation. Keep container tightly closed. Open and handle container with care. Do not eat, drink, or smoke while handling.

Conditions for safe storage, including any incompatibilities: Store in a tightly-closed

container when not in use. Store in a cool, dry, well-ventilated area away from incompatible substances. Keep away from sources of ignition. Store long-term in a cool, dry place.

Personal protection

Eyes: Based on an evaluation of the eye or face hazards present, wear chemical splash-resistant safety glasses or goggles with side protection. A face shield may be appropriate in some workplaces. Use eyewear tested and approved under appropriate government standards such as OSHA 29 CFR 1910.133 or EU EN166.
