

**CLEANING AND CARE OF YOUR FURNITURE**

This furniture is manufactured with a high quality melamine laminate finish and durable PVC edging. It is highly resistant to common hazards such as scratches, peeling, dents, moisture and heat. During the manufacturing process some glue residue may be left on the panels. This is normal, and this residue can be easily removed with a soft cloth moistened with isopropyl (rubbing alcohol). For regular maintenance of your furniture use a soft cloth with a mild cleaning solution. Never use abrasives or harsh chemicals.

**Importante:**

**Limpieza y cuidado de su mueble**

Este mueble es hecho con madera laminada de alta calidad, con molde durable de PVC. Es totalmente resistente a cosas comunes como rallones, golpes, humedad y calor. Durante el proceso de hacereste mueble un poco de pega podría ser hallado en los paneles, eso es normal, ese residuo puede ser facilmente removido con un paño suave humentado con alcohol. Para mantenimiento regular de este mueble, use un paño suave con una solucion no agresiva. Nunca debe de usar productos quimicos fuertes o, abresivos.







• TURN OVER BK&BKT THE HOLES SIDE TOWARDS THE BACK





This is your sole and exclusive remedy. This warranty is subject to the provisions below. It applies to product manufactured after May 29, 2005, for products sold within the United States of America and the Commonwealth of Canada.

### Limitations:

- Damage caused by the carrier in-transit is handled under separate terms as defined by the carrier.
- Fabric, vinyl and/or leather is warranted for two (2) years from the date of original purchase of the chair by the original owner of the Alera® product in question.

### Exclusions:

This warranty does not apply and no other warranty applies to:

- Normal wear and tear, which are to be expected over the course of ownership.
- Modifications or attachments to the product that are not approved by USSCo.
- Products that were not installed, used or routinely and properly maintained in accordance with product instructions and warnings.
- Products used for rental purposes.

USSCo does not warrant the color-fastness or matching of colors, grains or textures of covering materials.

2. Following your claim, your Reseller will conduct an inspection and review. During this time your Reseller or their appointed servicing agent will gather all pertinent information regarding the claim, inspect the product and contact a USSCo customer service representative. Please allow a reasonable amount of time for these activities.
3. A customer service representative or another representative of USSCo will determine whether to provide replacement parts, authorize repairs or replace the product providing USSCo affirms that the product in question is eligible under the conditions of the warranty as stated above.
