SECTION 4 - FIRST-AID MEASURES

4.1 Description of first aid measures

General advice: Consult a doctor and show this safety data sheet.

7.2 Conditions for safe storage, including any incompatibilities: Store in cool, well-ventilated area. Keep away from direct sunlight. Keep container tightly sealed until ready for use. Keep in a dry place. Store at room temperature.
