SECTION 4 - FIRST-AID MEASURES

4.1 Description of first aid measures

SECTION 7 - HANDLING AND STORAGE

7.1 Precautions for safe handling: Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing.
