Skin Contact	If the chemical contacts a clothed portion of the body, remove the contaminated clothes as quickly as possible, protecting your own hands and body. If the chemical touches the victim's exposed skin, such as the hands: Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap.
