Section IV. First Aid Measures

Eye Contact	Check for and remove any contact lenses. IMMEDIATELY flush eyes with running water for at least 15 minutes. Keeping eyelids open. COLD water may be used. DO NOT use an eye ointment. Skin Contact	After contact with skin, wash immediately with plenty of water. Gently and thorough wash the contaminated skin with running water and non-abrasive soap.
