Environmental Fate	Bis(2-hydroxy-3-tert-butyl-5-methylphenyl) methane's production and use as a stabilizer used in styrenic and olefin polymers and polyoxymethylene homo and copolymers, and as an antioxidant may result in its release to the environment through various waste streams. Bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane has been detected in drinking water, carpets, and in human adipose tissue. If released to soil, bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane will be immobile. Volatilization of bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane should not be important from moist or dry soil. Based on a MITI biodegradation test, bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane will not biodegrade in soil. If released to water, bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane will adsorb to suspended solids and sediment. Bis(2-hydroxy-3-tert-butyl-5-methylphenyl) methane may not volatilize from water surfaces based on an estimated Henry's Law constant of 7.9×10^{-12} atm-cu m/mole. Experimental BCF values of 23-37 and 60-125 suggest that bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane will bioconcentrate in aquatic organisms. Based on a MITI biodegradation test, bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane will not biodegrade in water. If released to the atmosphere, bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane will exist in the particulate phase. Particulate-phase bis(2-hydroxy-3-tert-butyl-5-methylphenyl)methane may be physically removed from the air by wet and dry deposition. (SRC)
