Section IV. First Aid Measures

Environmental Fate Phthalamide's production and use as an intermediate in organic synthesis and as a laboratory reagent may result in its release to the environment through various waste streams. If released to soil, phthalamide should have very high mobility. Volatilization of phthalamide may not be important from moist or dry soil surfaces. Insufficient data are available to determine the rate or importance of biodegradation of phthalamide in soil or water. If released to water, phthalamide would not adsorb to suspended solids and sediment. Phthalamide would be essentially non-volatile from water surfaces. An estimated BCF value of 0.03 suggests that phthalamide will not bioconcentrate in aquatic organisms. If released to the atmosphere, phthalamide will exist primarily in the particulate phase. Vapor-phase phthalamide is degraded in the atmosphere by reaction with photochemically produced hydroxyl radicals with an estimated half-life of about 3.4 days. Particulate-phase phthalamide may be physically removed from the air by wet and dry deposition. (HSDB)
