Section VI. Accidental Release Measures

Spill Cleanup Instructions Corrosive material. Air sensitive material. Stop leak if without risk. Absorb with DRY earth, sand or other non-combustible material. DO NOT get water inside container. DO NOT touch spilled material. Use water spray curtain to divert vapor drift. Prevent entry into sewers, basements or confined areas; dike if needed. Eliminate all sources of ignition. Consult federal, state, and/or local authorities for assistance on disposal.

Environmental Fate Aquatic: In the case of a solid, anhydrous sodium hydroxide spill on soil, ground water pollution will occur if precipitation occurs prior to clean up. Precipitation will dissolve some of the solid (with much heat given off) and create an aqueous solution of sodium hydroxide, which then would be able to infiltrate the soil. However, prediction of the concn and properties of the solution produced would be difficult.
