Section IV. First Aid Measures

Skin Contact	After contact with skin, wash immediately with plenty of water. Gently and thoroughly wash the contaminated skin with running water and non-abrasive soap. Be particularly careful to clean folds, crevices, creases and groin. COLD water may be used. Cover the irritated skin with an emollient. Seek medical attention. Treat symptomatically and supportively. Wash any contaminated clothing before reusing.
Inhalation	If the victim is not breathing, perform artificial respiration. Loosen tight clothing such as a collar, tie, belt or waistband. If breathing is difficult, oxygen can be administered. Seek medical attention. Treat symptomatically and supportively.
Ingestion	INDUCE VOMITING by sticking finger in throat. Lower the head so that the vomit will not reenter the mouth and throat. Loosen tight clothing such as a collar, tie, belt, or waistband. Environmental Fate	2,2,4-Trimethyl-1,3-pentanediol may be released to the environment in waste water effluents generated at sites of its production and use as a chemical intermediate. Use as a solvent in printing inks could result in evaporation to the atmosphere. If released to the atmosphere, it will degrade in the vapor-phase by reaction with photochemically produced hydroxyl radicals (estimated half-life of 22 hours). If released to soil or water, an estimated Koc value of 19 suggests that 2,2,4-trimethyl-1,3-pentanediol will leach readily. 2,2,4-Trimethyl-1,3-pentanediol has been identified in one human breast milk sample; therefore, the infant population may be exposed through breast feeding. Occupational exposure to 2,2,4-trimethyl-1,3-pentanediol can occur through dermal contact and inhalation. (SRC)
